



Step 1:

If you have not yet downloaded the App, search for “Credit Suisse WM APAC” app on the App Store or Google Play.

Launch the App on your mobile device or access the web version at www.credit-suisse.com/apac/app.


Tap on "First time user".

Step 2:

Enter the mobile number that you have registered to use with the App.

A security code will be sent via SMS to your mobile device.

Enter the security code and answer the security questions to complete the authentication process.




Step 3:

Create your new password.

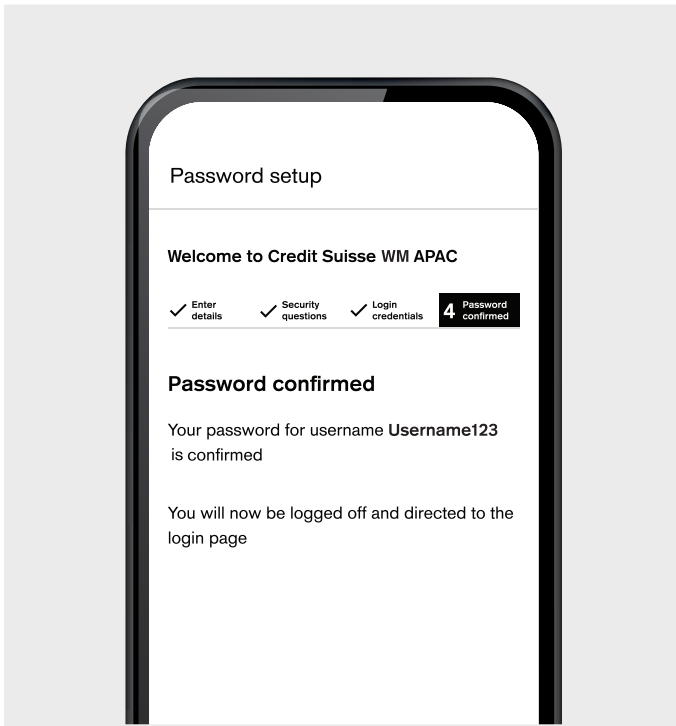
Tap "Continue".

You can now log in to the Credit Suisse WM APAC app using your username and new password.



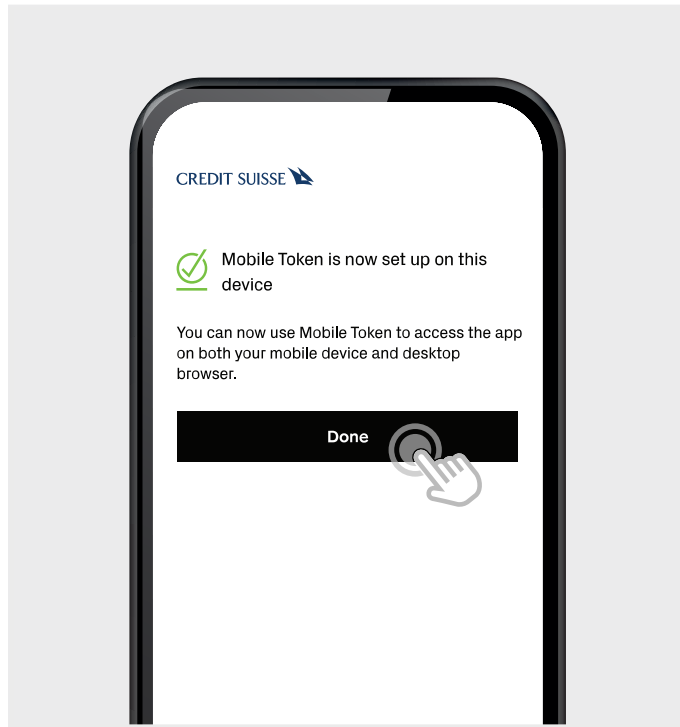
Step 2:
