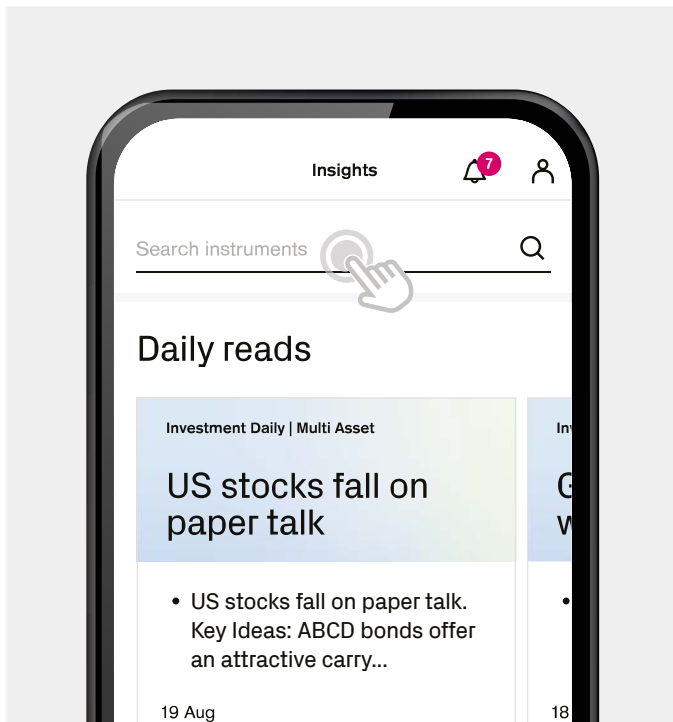

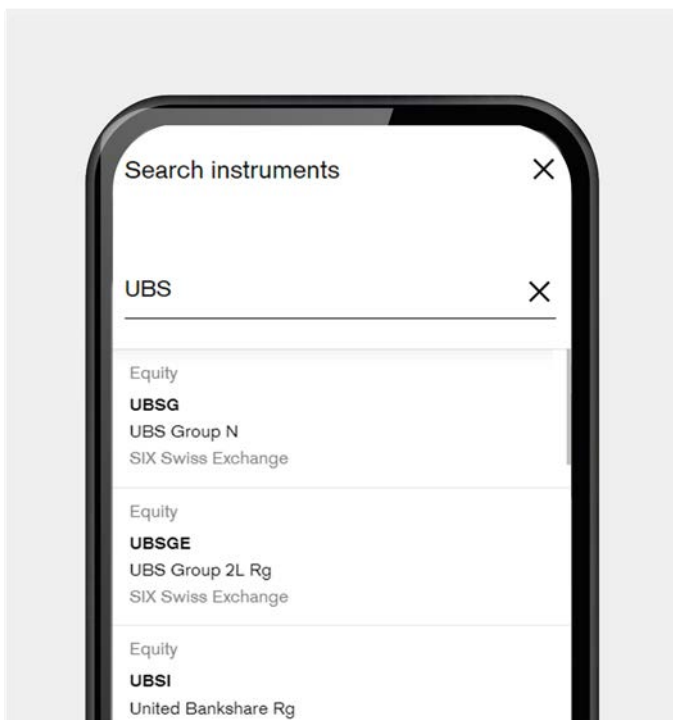

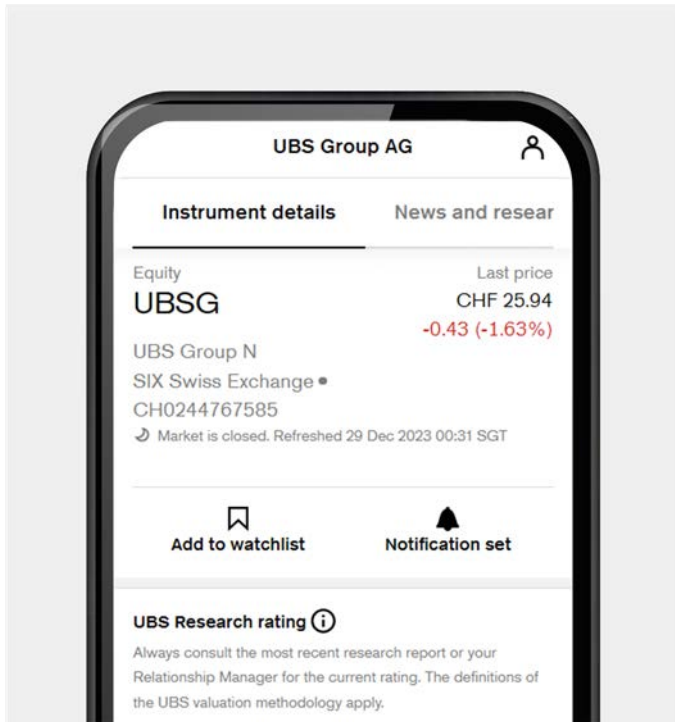
Search for Instruments

With the new search bar, you can quickly search for instruments of interest.



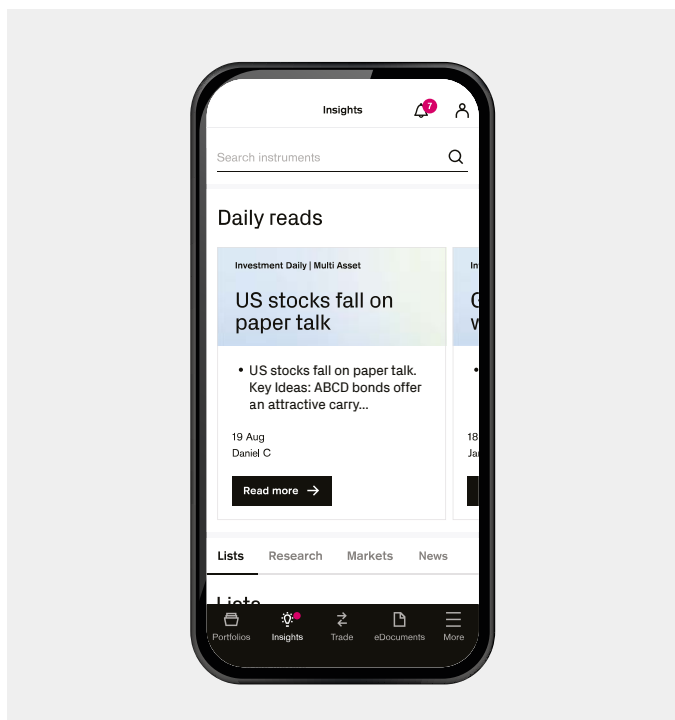
Start by typing a company’s name, ISIN or ticker into the search bar, which leads you to a list of instruments matching your search criteria.





From here, you may select your intended instrument to view performance, read insights from Credit Suisse/UBS Research, review ratings and third-party indicators, read up on related research, news and more.

Take other actions such as saving the instrument to your watchlist, set notifications to receive updates on price movements via preferred channels or choose to “Buy” or “Sell”.

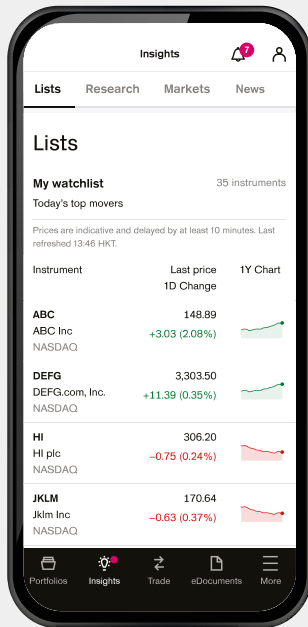

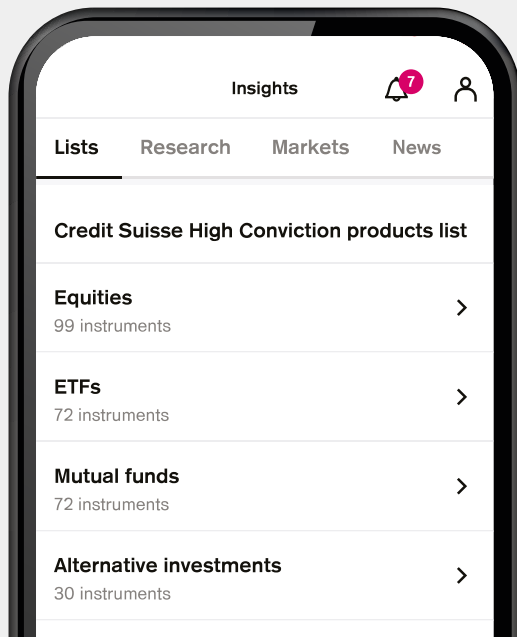

Scroll down to “My watchlist” to keep track of your curated list of instruments, including the latest price changes and one-year price trends.

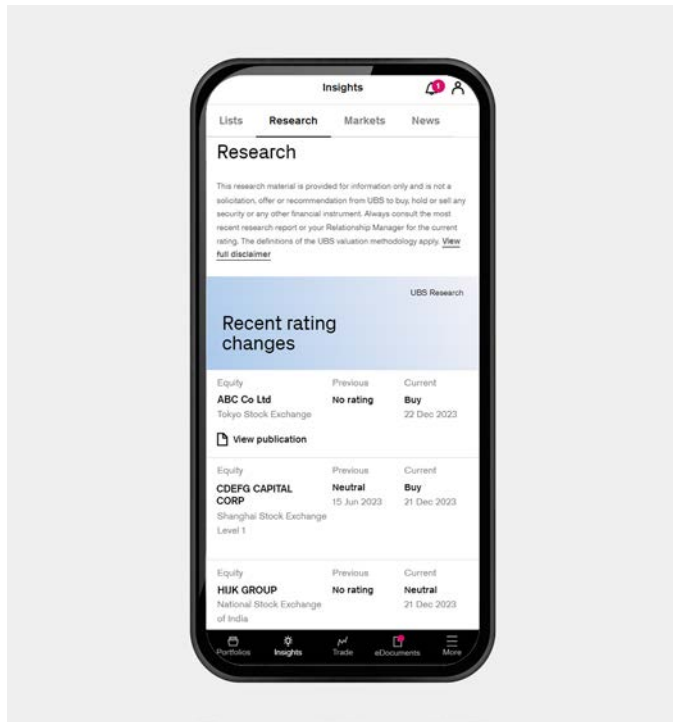

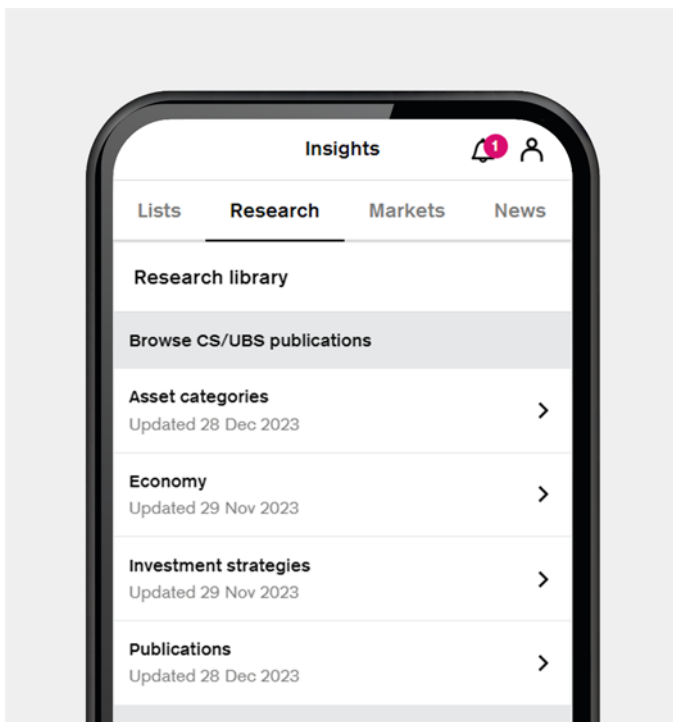


Research

Under “Recent rating changes”, keep track of rating changes from Credit Suisse/UBS Research.

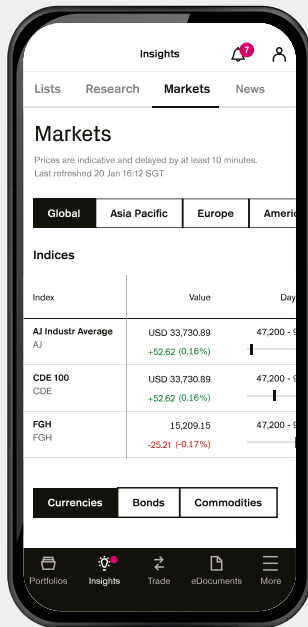

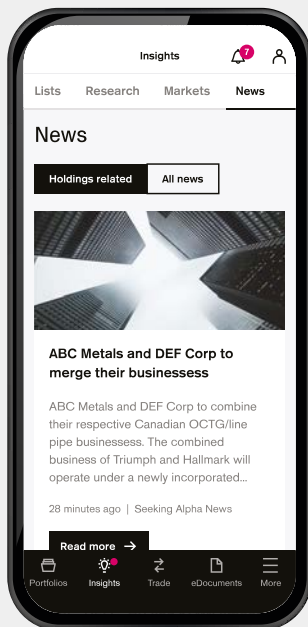
