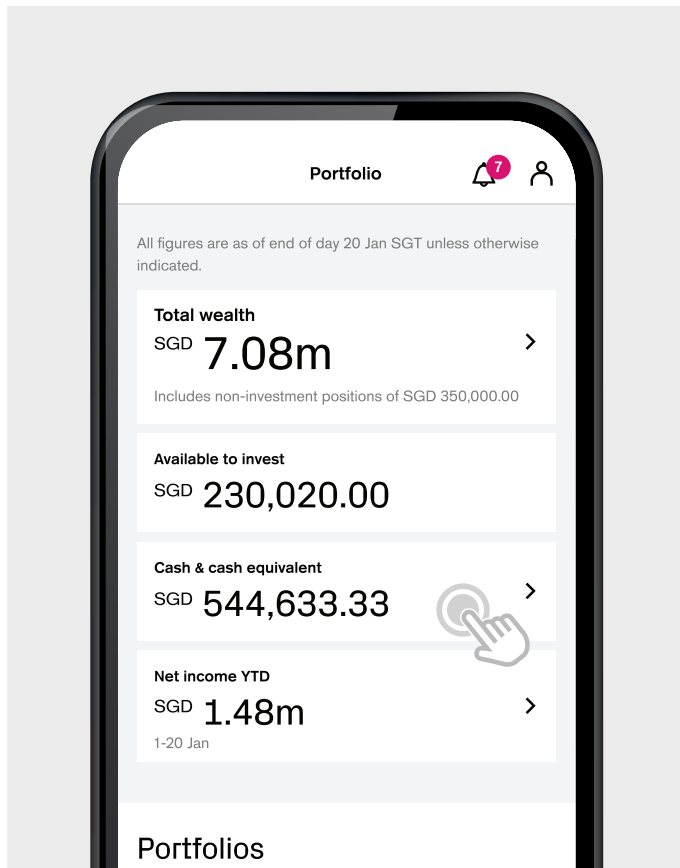

Upon login, you will see an overview of your portfolio valuation - total wealth, available to invest, cash & cash equivalent, and net income Year-To-Date (YTD), consolidated across your portfolio group.

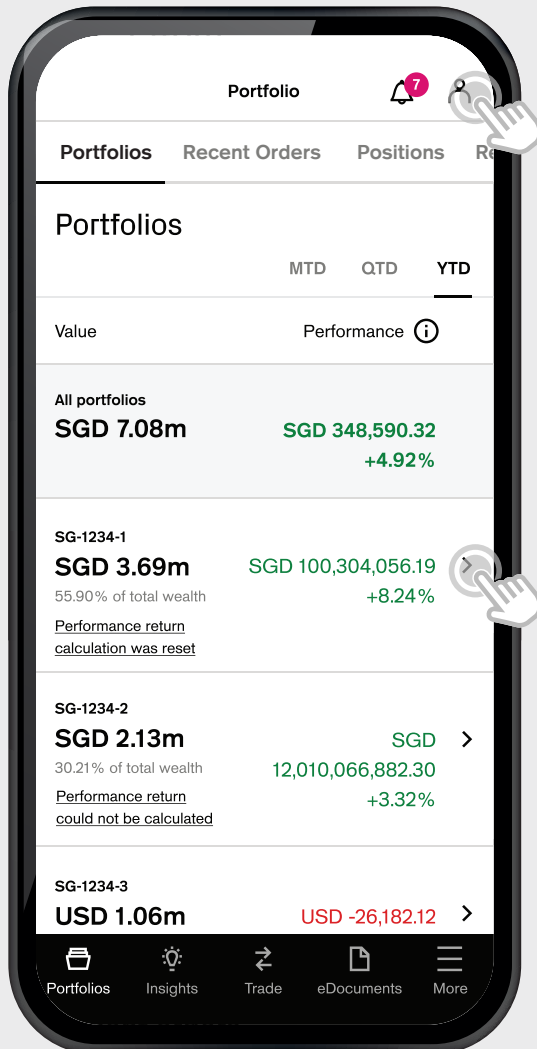
You can tap on each card to view more details. For example, by tapping on "Cash & cash equivalent", you are able to view all cash accounts (including forward transactions) linked to all portfolios.

Scrolling down, you will see a list of all portfolios tagged to your portfolio group.

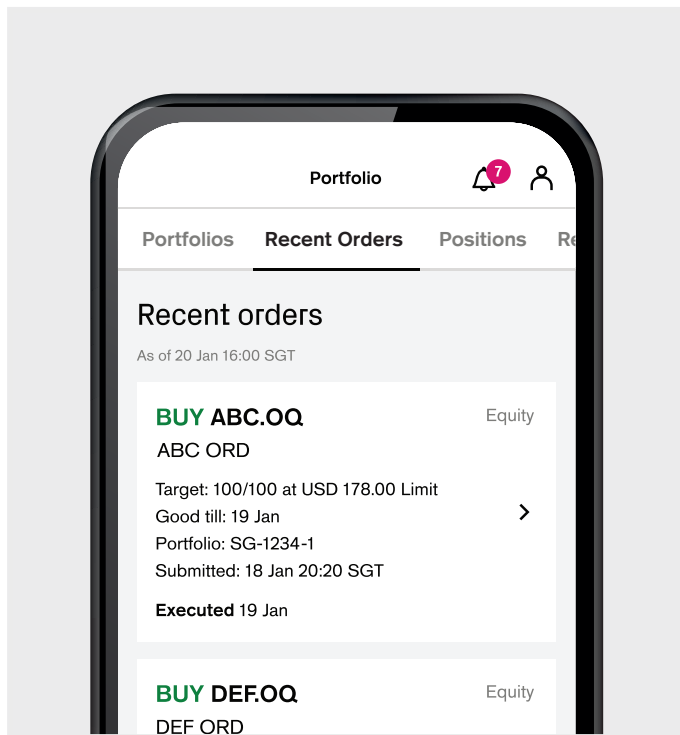
If you wish to view the portfolios tagged to another portfolio group, tap on the icon  (containing your account number) at the top right corner of your screen.

Recent Orders

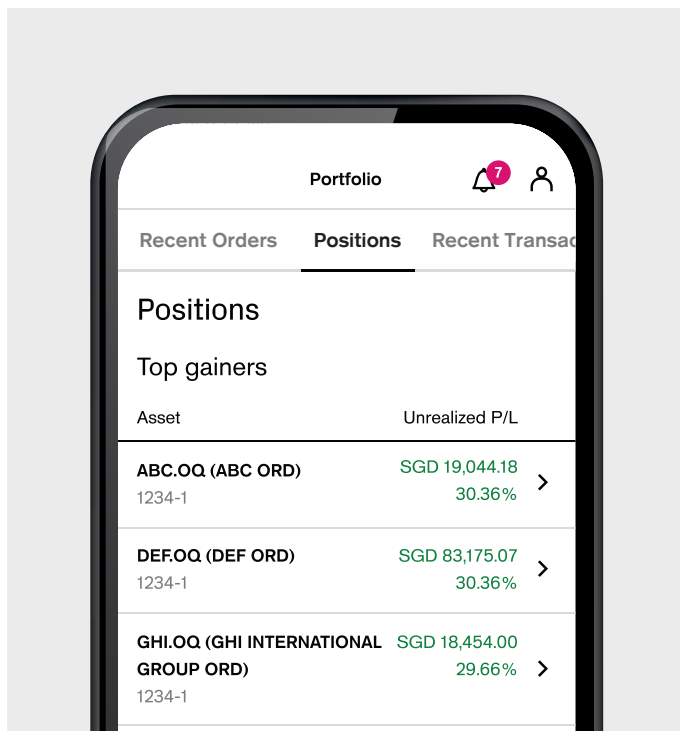
Here you can view your 3 most recent orders (Equities, FX Spot and FX Forward) placed with Credit Suisse, along with the updated status and details of each order.



Positions


View a breakdown of your positions with useful filters such as gainers and losers.


