



Renaming of Umbrella and Subfunds

CS SICAV One (Lux) CS Solutions (Lux)

Effective **July 4, 2014**, the CS SICAV One (Lux) and CS Solutions (Lux) umbrella funds were renamed CS Investment Funds 2 and CS Investment Funds 4 respectively. All subfunds within these umbrellas were also renamed to reflect the changes.

These changes are the latest steps in a series of name changes announced in April 2013. The Swiss security numbers (valor) and ISINs of the affected funds remain unchanged as well as the investment policy and fund management remain unaltered.

Upon renaming, the legal name of the respective umbrella fund is no longer an integral part of the fund names used in communications.

In addition to the changes indicated above, **further amendments** have been made to the Prospectus. The amendments were published in the Swiss Official Gazette of Commerce (SOGC) and at www.swissfunddata.ch on July 4, 2014 (CS SICAV One [Lux]) and July 28, 2014 (CS Solutions [Lux]). The official publication for Switzerland is only available in German.
