



## Renaming of Umbrella and Subfunds

CS Equity Fund (Lux)  
CS Portfolio Fund (Lux)  
CS Fund (Lux)  
CS Bond Fund (Lux)

Effective **January 16, 2015**, the Credit Suisse Equity Fund (Lux), and Credit Suisse Portfolio Fund (Lux) umbrella funds have been renamed CS Investment Funds 11 and CS Investment Funds 12 respectively.

Effective **February 17, 2015**, the Credit Suisse Fund (Lux) and the Credit Suisse Bond Fund (Lux) umbrella funds have been renamed CS Investment Funds 13 and CS Investment Funds 14 respectively.

All subfunds within these umbrellas are also renamed to reflect the changes.

Regarding the umbrellas CS Investment Funds 13 and 14, the accounting year-end will be changed for all affected funds, moving from September 30 to March 31. The first new financial year will run for six months to March 31, 2015. Accordingly, the distribution payments will only reflect this time period and thus be considerably smaller compared to previous years. The next distribution is scheduled for May 19, 2015 (ex-date).

These changes are the latest steps in a series of name changes announced in April 2013. The Swiss security (valor) number and ISIN of the affected funds remain unchanged and the investment policy and fund management also remain unaltered.
