**Notice to the Shareholders of CS Investment Funds 3 – Credit Suisse (Lux) European Corporate Opportunities Bond Fund**

Notice is hereby given to the Shareholders of CS Investment Funds 3 – Credit Suisse (Lux) European Corporate Opportunities Bond Fund (the "Subfund") that the Board of Directors of the Company has put the Subfund into liquidation as of 6 April 2016, in accordance with the notice to Shareholders published on 1 March 2016.

The net liquidation proceeds per Share of the Subfund, which have been calculated on 6 April 2016, were credited to the respective depositary/Shareholder in kind with value date as of 8 April 2016. Accordingly, Shareholders of the respective classes received assets of the Subfund, consisting of shares in **Credit Suisse (Lux) Global Value Bond Fund**, a subfund of CS Investment Funds 1 (the "Target Fund").

Any liquidation proceeds that cannot be distributed to the Shareholders at the closure of the liquidation shall be deposited with the "Caisse de Consignations" in Luxembourg until the statutory period of limitation has elapsed.

After closure of the liquidation, the accounts and the books of the above-mentioned Subfund shall be filed with Credit Suisse Fund Services (Luxembourg) S.A., during a period of five years.
