Notice is hereby given to the Shareholders of **Credit Suisse (Lux) Multi-Advisor Equity Alpha Fund** (the "Subfund") that the Board of directors has decided to change the expected level of leverage from approximately 2 to approximately 2.5 times of the Subfund's Net Asset Value due to an increased use of total return swaps and contracts for differences. The Subfund's supplement has been amended to reflect the above changes.

Shareholders of the Subfund who do not agree with the changes listed under point 2 may redeem their shares free of charge until 10 October 2018, 3 p.m. CET.

All changes will enter into effect on 11 October 2018.

Shareholders should note that, once the above changes enter into effect, the new prospectus of the Company, the Key Investor Information Document (KIID), the latest annual and semi-annual reports as well as the articles of incorporation may be obtained at the registered office of the Company in accordance with the provisions of the prospectus.
