As a result, shareholders will not be able anymore to subscribe in shares of the Subfunds in Bahrain, Finland, Liechtenstein, Netherlands, Norway and Sweden as of 1 November 2018. However, shareholders of the Subfunds will maintain the possibility to redeem their shares free of charge, in line with what is mentioned in the sales prospectus.

Shareholders should inform themselves as to the possible tax implications of the aforementioned change in their respective country of citizenship, residence or domicile.

Copies of the prospectus of the Company, the key investor information documents as well as the articles of incorporation may be obtained in accordance with the provisions of the sales prospectuses at the registered offices of the Company or on the internet at [www.credit-suisse.com](http://www.credit-suisse.com), until 31 October 2018.

Once the above changes enter into effect, the new prospectus of the Company, the relevant Key Investor Information Document (KIIDs), the latest annual and semi-annual reports as well as the articles of incorporation may be obtained at the registered office of the Company in accordance with the provisions of the prospectus.
