## PROPÓSITO DEL DOCUMENTO

El propósito de este documento es el de difundir a los diferentes usuarios de la información financiera aspectos relevantes sobre los rubros que forman parte de los estados financieros consolidados del Grupo Financiero Credit Suisse México, S.A. de C.V. con cifras al 31 de Marzo de 2009, atendiendo al principio de importancia relativa a que se refiere el Boletín A-6 del Instituto Mexicano de Contadores Públicos.A.C.

Así mismo se está dando cumplimiento a las Disposiciones de Carácter General Aplicables a la Información Financiera de las Sociedades Controladoras de Grupos Financieros publicado en el Diario Oficial de la Federación el día 30 de Junio de 2005.

## ANTECEDENTES

Grupo Financiero Credit Suisse México.S.A. de C.V. (el Grupo) se constituyó como una institución controladora filial el 21 de febrero de 2002. El 25 de Junio de 2002, la Secretaría de Hacienda y Crédito Público (SHCP) emitió una resolución mediante el cual se autorizó la organización y operación del Grupo.

La principal actividad del Grupo es actuar como tenedora de las acciones con derecho a voto emitidas por entidades financieras filiales y demás sociedades autorizadas por la SHCP para formar parte del Grupo y realizar toda clase de actividades financieras relacionadas con la compra-venta y tenencia de acciones de subsidiarias en los términos de la Ley para Regular las Agrupaciones Financieras (LRAF) y de las demás leyes aplicables.

Las presentes notas explican a mayor detalle la naturaleza y monto de conceptos del balance general y estado de resultados que hayan modificado sustancialmente su valor y que produzcan cambios significativos en la información financiera del periodo intermedio.

Todos los rubros que forman parte del Balance General y Estado de Resultados han presentado cambios significativos con respecto a periodos anteriores toda vez la operación del Grupo se ha incrementado desde su inicio de operaciones, como sigue:

## **1. BALANCE GENERAL**

### **1.1 Disponibilidades**

El saldo por \$1,726 está integrado principalmente por depósitos en Instituciones del extranjero, depósitos en el Banco Central, en otras Instituciones de Banca Múltiple, depósitos a plazo y por préstamos interbancarios pactados a un plazo menor o igual a 3 días hábiles bancarios.

### **1.2 Inversiones en Valores**

Las inversiones en valores se clasifican atendiendo a la intención de la administración sobre su tenencia. Al cierre del trimestre, el Banco y la Casa de Bolsa mantenían una posición de títulos para negociar por \$3,361 integrados por valores emitidos por el Gobierno Federal, Certificados de Participación Carretera y Certificados Bursátiles emitidos por Otras Empresas.

Los títulos para negociar se registran al costo y se valúan utilizando los precios proporcionados por un proveedor independiente. Los efectos de valuación se reconocen en el estado de resultados dentro del rubro de "Resultado por Intermediación".

### 1.3 Cartera de Crédito

El banco no ofrece productos de crédito por lo que los activos del Grupo se forman principalmente por posiciones propias, activos fijos y deudores diversos ya sea por operaciones fecha valor o por ingresos de operaciones con afiliadas pendientes de recibir e impuestos diferidos a favor.

### 1.4 Otras cuentas por Cobrar

Los \$ 6,467 están integrados por operaciones fecha valor 24,48,76 y 96 horas de títulos para negociar, por pesos a recibir por las operaciones de compraventa de divisas con vencimiento 24 y 48 horas del Banco, por cuentas por cobrar con filiales del extranjero por contratos de mediación celebrados por las subsidiarias del Grupo, comisiones por cobrar por operaciones del mercado de capitales con vencimiento 24 y 48 hrs., así como por saldos a favor de impuestos.

## 1.8 Prestamos Interbancarios y de Otros Organismos

Las operaciones de préstamos interbancarios de exigibilidad inmediata conocidos como “call Money” son a plazos menores de 3 días; al 31 de Marzo de 2009 se tenía posición en préstamos interbancarios por un importe de 1,684, mientras que en el trimestre anterior se tenía posición por un importe de 1,928.

Las variaciones entre los periodos mencionados, obedecen a necesidades específicas de la liquidez que el Banco requiere; los intereses a cargo por este tipo de operaciones se reconocen en el estado consolidado de resultados conforme se devengan.

## 1.9 Operaciones con Valores y Derivadas

Los valores reportados a recibir o a entregar se valúan al valor razonable de los títulos proporcionado por un proveedor de precios independiente, y el derecho u obligación por el compromiso de recompra o reventa, al valor presente del precio al vencimiento; se presenta en el balance general la diferencia entre ambos valores actualizados. Las operaciones en las que el Banco actúa como reportado y reportador con una misma entidad no se compensan.

Las operaciones con instrumentos financieros derivados se realizan para fines de negociación y se presenta dentro del Balance General el neto de las posiciones valuadas a valor razonable utilizando para ello valores proporcionados por un proveedor de precios independiente.

Al 31 de Marzo de 2009 el rubro de Operaciones con Valores y Derivadas está integrado por operaciones del Banco y se detalla como sigue:

## 1.10 Cuentas por Pagar
