Which platform will be used for the 1on1/small group meetings?

Zoom will be the platform used for 1on1/small group meetings.

Will there be an operator on my 1on1/small group conference call meeting?

Yes, we will be using OpenExchange who are a third party that will be operating the calls to ensure all the attendees have joined the meeting and that it runs smoothly.

Prior to the conference, we will send you a test link. This will be a 5-minute process where you will work directly with OpenExchange to check that the call operates correctly for you and also to familiarise yourself with the video conferencing platform.
