Requirements

- Business Easy Overdraft is available only in conjunction with a Startup Easy or Business Easy Corporate account in Swiss Francs
- Minimum account turnover: CHF 75,000/year
- Low seasonal fluctuations in turnover

- Business Easy Overdraft will be granted only if the banking relationship with Credit Suisse has existed for at least six months²
- No existing financing with Credit Suisse
- Sufficient creditworthiness

Conditions

- Interest: 9.5% annual rate
- Credit commission: 0.25% quarterly on highest sum borrowed; max. 50% of debit interest amount
- The overdraft limit is calculated automatically on a monthly basis, and can therefore vary from month to month between CHF 0, CHF 3,000, CHF 5,000, and CHF 10,000. The calculation depends on the account turnover and assets held with Credit Suisse²
- A one-time processing fee of CHF 30 will be charged when you apply via online banking with Credit Suisse Direct; the fee is CHF 150 for manual processing by the Relationship Manager³
