In stores and at vending machines

You can use the new debit card to pay at over 43 million points of sale.



Contactless

Pay amounts of less than CHF 80 in a matter of seconds without having to enter your PIN. For larger payments, your PIN will be automatically required for security reasons.



Online payments

The Debit Mastercard also allows you to pay securely and conveniently on the internet and via apps. Extra security is provided using 3D Secure – a process through which you confirm payments to online merchants using your mobile phone.



Making cash withdrawals and deposits

You can withdraw cash anywhere in the world. In Switzerland, cash deposits can be made at designated Credit Suisse ATMs.



Keep track of your expenses and card

Payments and cash withdrawals are immediately debited from your account. This helps you keep a close eye on transactions executed as well as the current balance in your account at all times.

You can customize your debit card's security settings according to your personal needs via online and mobile banking.*
