

#### What you need to know about the IBAN

The International Bank Account Number (IBAN) is an international standard for representing the account number. It allows account numbers to be uniquely validated worldwide. The length of the IBAN differs from country to country. In Switzerland, it always comprises 21 characters. To make it easier to read, on paper the IBAN is divided into groups of four characters:



#### Where can you find your IBAN?

- On Credit Suisse account statements, credit and debit advice slips
- In Online Banking (subheading Account)
- On red payment slips
- On your Maestro card

#### Your needs

- You want to make payments in Switzerland and Europe.
- You want your payments to be processed quickly, reliably, and cheaply.

- No searching for the bank clearing number



#### Terms and conditions

- Use your IBAN for payment transactions in Switzerland
- Payments in the EU/EEA using the SEPA standard:
  IBAN and business identifier code (BIC) required (BIC address of Credit Suisse: CRESCHZZ80A)
- Extra charge for euro payments without IBAN/BIC in the EU/EEA due to processing or return costs
