Introduction

These reports with Top 5 execution venues and Top 5 brokers refer to the obligations set out in art. 27.6 of Directive 2014/65/EU ("MiFID II") and art. 3 of Commission Delegated Regulation (EU) 2017/576 ("RTS 28"), and outline the identity of the main execution venues, in terms of volume, where Credit Suisse AG and Credit Suisse (Switzerland) Ltd. (hereafter "Credit Suisse") have actively executed clients' orders, and the main brokers, in terms of volume, where Credit Suisse has routed its clients' orders for further execution both for retail and professional clients, in the preceding year.

This report is intended to cover the period from 1/1/2021 to 31/12/2021 inclusive. Given that Credit Suisse is not a firm directly subject to MiFID II provisions, it is not directly obliged to comply with the best execution requirements, but endeavours to do so in order to provide the best service to its clients.
