

Explanations on the Release/Transfer of the Rental Deposit

Please observe the following points to prevent delays in the processing of your application:

- The instructions to close an account must contain **original signatures**. We cannot accept forms that are copies or scans.
- Please also enclose **copies of the relevant ID cards or passports** with your instructions to close an account to make it easier for us to verify and identify the authorized persons.
- Please check the **information for transferring the rental deposit**, such as the **account number (IBAN)**, to ensure it is correct (for instance, based on your Maestro card or bank/post office account documents).
- Changes and corrections on the form made individually by the tenant or lessor must always be confirmed by all parties.
- In the event of one party's death, we will need the consent of the legal heirs to dissolve the account of the deceased party, plus the following supplemental documents:
 - Death certificate (as legal proof of death)
 - Inheritance certificate (as proof of status as legal heir)
 - Copies of the heirs' ID cards or passports (to identify them)
 - If applicable, any certificates of executorship and powers of attorney (including copies of the ID cards of the individuals concerned)
- Please send the completed form signed by both parties directly to the address below. Handing it in at the counter or sending it to a branch or client advisor may result in delays.
