## Withdraw cash conveniently worldwide at favorable rates.

### What you should know about the Travel card

Before traveling, simply load your Travel card like a prepaid card at a Credit Suisse counter, and then make cash withdrawals or cashless payments in stores and online anywhere in the world.

- The Travel card is a further development of the well-established Travelers Cheques and can be used wherever Mastercard is accepted.
- If your Travel card is lost or stolen, it will be replaced (including the remaining balance) free of charge anywhere in the world.

### Requirements for issuance of card

- Domicile in Switzerland or Liechtenstein
- Private or current account with Credit Suisse in the name of the cardholder
- Minimum age of 12 years
- Max. five Travel cards per client

- You want a convenient and safe way to travel, a flexible way to withdraw local currency – and adequate protection.

Load fee	1.5% of the load amount each time you load
Load commission	Additional CHF 10 for reloading at the counter (initial load excluded)
Cash withdrawals at ATMs (per withdrawal) <sup>3</sup>	Switzerland: CHF/EUR/USD 5 (depending on the card currency) Abroad: CHF/EUR/USD 7.50 (depending on the card currency)
Purchases (per payment)	CHF/EUR/USD 1 (depending on the card currency)

You will usually receive your Travel card within one to two working days.

You can obtain information on your card status on the internet,<sup>2</sup> via the Credit Suisse Prepaid Cards app,<sup>1</sup> at all ATMs in Switzerland, or directly by telephone from Swiss Bankers Customer Service (+41 31 710 12 15).\*
