



## CS Bond Fund (CH) Dynamic International

Dear Sirs

**Effective as of March 27, 2015**, the Credit Suisse Bond Fund (CH) Dynamic International will be repositioned and rebranded to the Credit Suisse (CH) Sustainable International Bond Fund.

### Key characteristics:

- The repositioning will be limited to securities selection. In the future, **sustainability criteria** (environmental, social and corporate governance criteria) will be integrated with the previous selection criteria, thereby reducing individual securities risks.
- The **investment policy will remain unchanged**, i.e. the fund will continue to invest in bonds with the aim of generating an above-average and regular stream of income. The benchmark will accordingly remain unchanged.
- In practice, the bulk of securities held in the fund **already meet the sustainability criteria** to be complied with in the future. The repositioning should therefore result in only modest changes.
- In addition, the repositioned fund will be managed by the **same fund manager** responsible for the previous fund.
- The **management fee** will remain **unchanged**.
