The name changes affecting these funds will take effect as of January 29, 2010.

The investment policy of these subfunds is being changed to the effect that at least 90% of the investments that they make in liquid assets will be in US dollars. In the case of those subfunds listed above whose reference currency is not US dollars, the unhedged (against the dollar) value of these investments will not be permitted to exceed 10% of the net asset value of the relevant subfund.

The new investment policy will enter into force as of January 29, 2010. The unit holders of the subfunds listed above have the option, until 15:00 on January 28, 2010, of redeeming their units free of charge if they do not agree to the aforementioned change.

The sales prospectus and simplified prospectus will be amended accordingly.


