

Market Update – PIIGS Exposure Levels in Swiss and Lux Funds



Concerns about eurozone debt levels have intensified with investors worried that the crisis could spread from the smaller countries to larger economies such as Italy and Spain. In recent days the European Central Bank (ECB) has been forced to intervene in markets by buying Italian and Spanish bonds with the aim of bringing down their cost of borrowing and helping them avoid a Greece-style bail out by the authorities.

In light of these concerns, and on demand from various clients, we would like to take this opportunity to provide an update on exposure levels of Credit Suisse funds to the above mentioned countries. In addition, following recent events in Japan, as well as concerns about Hungary's financial position, we have also included exposure levels to these two countries.
