

Market Update – PIIGS Exposure Levels in Swiss and Lux Funds



The European debt crisis remains at the forefront of investors' minds. While there appeared to be some respite at the end of October, with an expansion of the eurozone's main bailout fund and a 50% write down of Greek government debt, the situation remains critical. Yields on government debt of the weaker economies, namely Portugal, Ireland, Italy, Greece and Spain, continue to rise, highlighting the risk of default, while Greece, Italy and Spain all have new prime ministers in place in an effort to solve the growing problems.

In light of these concerns, and on demand from various clients, we would like to take this opportunity to provide an update on exposure levels of Credit Suisse funds to the weaker economies in eurozone region, namely Portugal, Ireland, Italy, Greece and Spain. In addition, following recent events in Japan, as well as concerns about Hungary's financial position, we have also included exposure levels to these two countries.
