

Market Update – PIIGS Exposure Levels in Swiss and Lux Funds



2013 has got off to a positive start for financial markets, with investor sentiment boosted by the temporary deal to stave off the US fiscal cliff. Investor concerns over Europe have also receded in recent months. Although the US deal between the White House and congressional Republicans has only postponed by two months negotiations over spending cuts and the government debt ceiling, Europe has started to surprise on the upside with positive economic data. The region is also making further structural progress and this should help maintain the positive sentiment in markets.

In light of the on going situation, and on demand from various clients, we would like to take this opportunity to provide an update on exposure levels of Credit Suisse funds to Portugal, Ireland, Italy, Greece and Spain.
