

Market Update – PIIGS Exposure Levels in Swiss and Lux Funds



Although financial market volatility has normalized somewhat in recent weeks, investors are still worried about the end of “cheap money”. However, with major economies still performing below their long-term growth trends, inflationary pressures will probably continue to subside. This will allow central banks to keep accommodative policies in place even if the US Federal Reserve tapers off its asset purchases. In addition, the European Central Bank recently reaffirmed its commitment to keeping policy conditions expansive for the foreseeable future and this should help to further stabilize economic activity. Turning to equity markets, while there may be short-term profit taking following recent gains, the medium-term outlook for stocks remains bullish in view of the steady recovery in economic activity.

Against this back drop, and on demand from various clients, we would like to take this opportunity to provide an update on exposure levels of Credit Suisse funds to Portugal, Ireland, Italy, Greece and Spain.
