## SEVENTH SUPPLEMENT DATED 26 FEBRUARY 2021

#### TO CREDIT SUISSE AG REGISTRATION DOCUMENT DATED 14 MAY 2020.

This supplement (the "Seventh Supplement") dated 26 February 2021 supplements the Registration Document dated 14 May 2020 and approved by the Financial Conduct Authority (the "FCA") on 14 May 2020 (the "Registration Document"). 1Q20) to the Form 6-K Dated 7 May 2020), in the Form 6-K Dated 30 July 2020 under the heading "Litigation" (note 32 to the condensed consolidated financial statements of Credit Suisse Group AG on pages 161 to 163 of the exhibit (Credit Suisse Financial Report 2Q20) to the Form 6-K Dated 30 July 2020), in the Form 6-K Dated 29 October 2020 under the heading "Litigation" (note 33 to the condensed consolidated financial statements of Credit Suisse Group AG on pages 150 to 151 of the exhibit (Credit Suisse Financial Report 3Q20) to the Form 6-K Dated 29 October 2020), in the Form 6-K Dated 1 December 2020, in the Form 6-K Dated 8 January 2021, and in the Form 6-K Dated 18 February 2021 under the heading "Litigation" on page 5 of the exhibit (Credit Suisse Earnings Release 4Q20) to the Form 6-K Dated 18 February 2021, there are no, and have not been during the period of 12 months ending on the date of this Seventh Supplement, governmental, legal or arbitration proceedings which may have, or have had in the recent past, significant effects on the Bank's financial position or profitability, and Credit Suisse AG is not aware of any such proceedings being either pending or threatened.

To the extent that there is any inconsistency between (a) any statement in this Seventh Supplement or any statement or information incorporated by reference into this Seventh Supplement and (b) any statement or information in or incorporated by reference into the Registration Document as supplemented by the Existing Supplements, the statements or information in (a) above will prevail.
